Unrecorded and condensed record of the minutes of a regular meeting of the City Council of the City of Minto, Walsh County, North Dakota, held on February 8, 2021 at 9:00 AM.

Mayor Larry Jamieson called the meeting to order and the pledge was recited. Present were Councilmen Lucas Kelley, Keith Shutt, John Narloch, and Thomas Sitzer.

Open petitions from the public: None

A public hearing for the completion of the Minto Housing Rehabilitation Project was held as part of the regular City Council meeting. Stacie Sevigny of the Red River Regional Council reviewed a project summary. The housing rehab project is now complete and 11 owner-occupied homes were rehabilitated at no cost to the homeowners. Common repairs included roofing, windows, doors, plumbing and electrical. All homeowners had to meet income requirements and a committee appointed by Mayor Jamieson assisted in management of the project. Results include:

- 11 homes rehabilitated during 2019-2020 construction seasons
- \$206,174 spent on rehabilitation (including hard and soft costs)
- Average spent per home was \$18,300
- Most expensive rehab was \$27,729; least expensive was \$10,767
- Average increase in true and full value was \$4,600

One of the funding sources, CDBG, requires a public hearing be held at the conclusion of the project to give citizens an opportunity to hear how the funds were implemented. There were no public comments received.

Minutes from the regular meeting held on January 12, 2021 were submitted for approval. Motion by Shutt to approve the minutes, seconded by Narloch, carried.

## Committee reports were given:

- Streets, Grounds & Lights: Discussion was held regarding the skating rink. Councilman Narloch stated that a committee has been formed to address the skating rink. Potential members are Heather Narloch, Tyler Narloch, Dawn Miller, Christian Miller, John Kennedy, Amy Grindahl and Trevor Grindahl.
- Employee Relations: Employee Relations Committee will meet in March.

An application for a gaming permit has been received from the Park River Fire Department. The Park River Fire Department will be informed that the Council has approved a gaming permit for the Minto JCS beginning July 1, 2021.

BE IT RESOLVED by the City Council of the City of Minto, North Dakota that the following monthly utility service rates are in effect:

Water base rate \$40.75

Water \$7.10/1000 gallons

Sewer \$15.00

Sewer commercial large user plus .5952380/1000 gallons over 6,720 gallons

Garbage residential curb side \$18.00 Garbage dumpster \$36.00/3 yds

Street Lights \$3.75
Forest \$2.00
Snow Removal \$10.00
Insect Control \$6.00

BE IT ALSO RESOLVED that all payments will be due on the 10th of the month and considered delinquent after that date. A 10% late fee will be applied to all delinquent accounts, and

BE IT ALSO RESOLVED that if the City receives a check from a customer that is returned by the bank for nonsufficient funds, that customer will be required to pay by money order, cashier's check or cash.

BE IT ALSO RESOLVED all customers will be a charged a \$75.00 deposit to be returned to the customer after two years if the account is in good standing, and the fee for turning the water on at the curbstop shall be \$100.00 nonrefundable.

BE IT ALSO RESOLVED any customer who has had their water turned off for late payment within the last six months will not be allowed to amass a balance of over \$250.00. If the balance accrues to over \$250.00 the customer will be given 24 hours to pay the balance in full. If the balance is not paid in full the water will be turned off at the curbstop until the balance is paid in full, including a \$100.00 reconnect fee. Water will be turned off for a minimum of 24 hours.
